1. Please type or print neatly (in ink). We will use what we can read or interpret.
2. Complete Sections A through C; complete Section D ONLY if Dam was leased at the time of breeding and/or kittening.
3. All Registered TCA Catteries should own a copy of the TCA Constitution and Bylaws, as well as each of the TCA Recognized Breed Standards. These are used by the Breeder to accurately describe the cats and kittens to be registered. Breed is defined as a TCA recognized breed, such as Traditional Siamese or Classic Siamese, not Siamese by itself. Colors allowed are defined in the Breed Standards. Patterns allowed are described in the Breed Standards.
4. A signed lease agreement must be sent to the TCA Head Registrar, concurrent with or prior to litter registration acceptance.
5. The Dam's owner's TCA Cattery name (or the lessee's) will appear as a prefix on the kitten's registered name. This will only apply to TCA Registered Catteries.
6. ALL signatures (where required) MUST be signed or application will be returned.
7. Completed individual kitten registrations will be mailed to the litter owner (Owner of Dam or Lessee)
8. Section A (Birth information) must be completed in full. Any incomplete applications will be returned.
